#### **PURPOSE:**

Develop and analyze alternatives to provide operational solutions and capital project recommendations to accommodate growing airport activity with a high level of customer service.

#### **ESSENTIAL FUNCTIONS:**

This list is ILLUSTRATIVE ONLY, and is not a comprehensive listing of all functions and duties performed. Essential duties and responsibilities may include, but are not limited to, the following:

#### **Terminal Planning Studies Management:**

- Develop scopes of work, procure consulting resources, negotiate fees, manage contracts, conduct stakeholder engagement, and document results.
- Lead terminal studies involving development and evaluation of alternatives for terminal operations and facilities.
- Terminal studies will consider functional relationships of facilities within the terminal as well as
  interface with landside and airside facilities and include both physical layouts and
  capacity/performance analysis of facilities using spreadsheet and microsimulation modeling of
  passenger and baggage processing.

## **Terminal Planning Point of Contact:**

- Subject matter expert for terminal facility planning, coordinating with stakeholders to facilitate problem definition and scope planning efforts to resolve issues.
- Responsible for drafting of facility layouts to test and evaluate alternatives to resolve operational and capacity issues.
- Conduct gap analysis to determine facility requirements and conduct capacity/performance analysis of terminal facilities using spreadsheet and microsimulation modeling.

# **KNOWLEDGE, SKILLS & ABILITIES:**

- Broad knowledge of airport and airline operations and facilities across all functional areas.
- Understanding of airport planning processes and project requirements.
- An understanding of the political landscape and often competing interests of airport stakeholder groups.
- Knowledge of functional roles of internal and external stakeholders, especially as they relate to planning for future facilities development and operational solutions.
- General understanding of the capital project development process, including facility planning, design development, and construction.
- Knowledge of environmental review requirements and processes for projects under NEPA and SEPA.
- Project management, negotiation, problem solving and analytical skills.
- Highly effective interpersonal skills. Strong oral, written, graphic and presentation communication skills.
- Proficient computer skills with the ability to effectively use MS office programs such as Project,
   Word, and Excel; as well as planning software programs, such as AutoCAD, GIS, and Tableau.
   Familiarity/proficiency with terminal modeling software such as ARCPORT, ARENA, & VISWALK.
- Ability to independently manage multiple projects and competing priorities.
- Ability to analyze complex data sets and interpret results.
- Ability to think critically and to make independent judgments and decisions.

- Ability to form effective working relationships with stakeholders and build consensus around projects involving complex and technical issues.
- Ability to synthesize information to effectively document planning analyses through technical report writing and to provide timely, accurate information with clear recommendations to decision makers.
- Ability to communicate complex information to a wide range of stakeholder groups with varying levels of topic area knowledge and expertise.
- Ability to weigh policy considerations when evaluating alternatives to provide comprehensive recommendations to decision makers.
