The Idaho Falls City Council approved Mr. Turner’s appointment at the City Council Meeting. He will begin his new role on February 1, 2024.

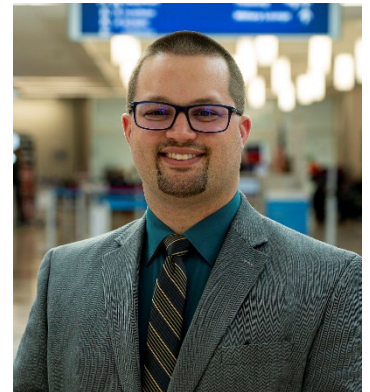
