VSE Milestones

- In 2023, VSE Aviation acquired Desser Aerospace's Distribution and MRO operations to expand distribution and MRO service offerings and geographic footprint.
- In 2022, GlobalParts.aero and Global Parts Aero Services take on the VSE Aviation brand as they are integrated into the business.
- In 2021, VSE Aviation acquired Global Parts Aero Services and GlobalParts.aero to expand distribution and MRO service offerings to the Business & General Aviation market.
- Also in 2021, Kansas Aviation and 1st Choice Aerospace renamed VSE Aviation Services to become the global MRO arm of VSE Aviation.
- In 2020, Air Parts & Supply Co. (APSCO) renamed VSE Aviation as it is integrated with VSE Aviation Singapore and VSE Aviation Germany to become the joint global Distribution arm of VSE Aviation.
- In 2019, 1st Choice Aerospace was acquired to expand MRO services to include Commercial and Cargo markets.
- In 2015, VSE Aviation acquired Air Parts & Supply Co. (APSCO) to support aftermarket distribution of the turbine engine accessories market.
- Also in 2015, VSE Aviation acquired Kansas Aviation to provide MRO services to the gas turbine engine market.

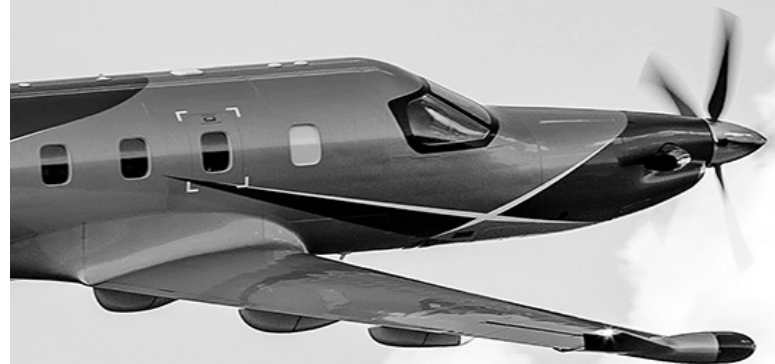




Preferred Education and Experience
