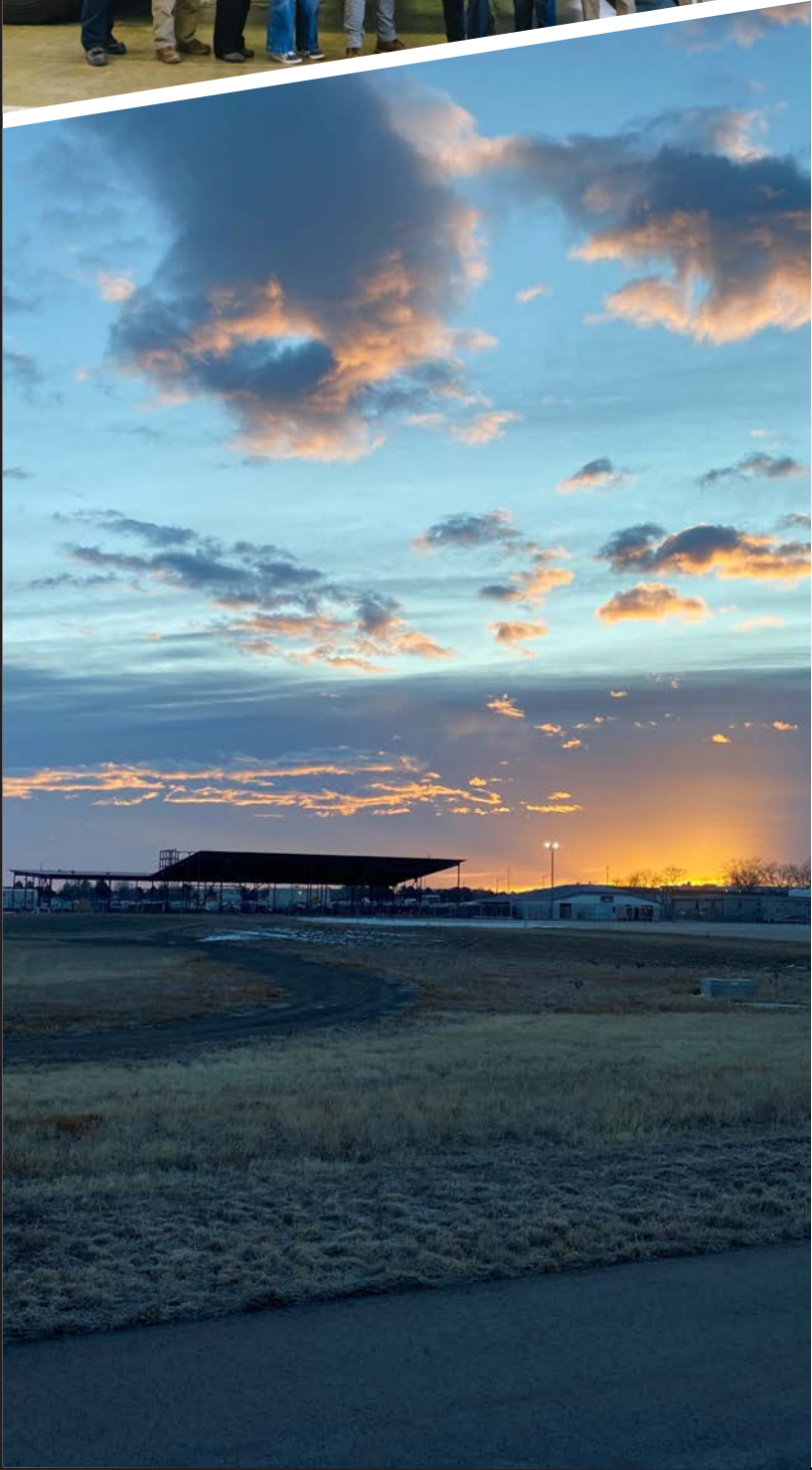

The Airport

FNL was established in 1963 when the Federal Aviation Administration (FAA) provided the Cities of Fort Collins and Loveland a land grant to acquire approximately 1,000 acres of land for the purpose of building an airport to replace two separate, smaller general aviation airports in each of the communities. The purpose was to encourage general aviation (private and corporate) and regional commuter air travel. The Airport facility opened to the public in 1966 with one Fixed Base Operator and one building with 10 T-hangar units. Airport ownership was split with two-thirds interest to Fort Collins and one-third to Loveland. In 1972 Mountain Air, Inc. and Goodrich Aviation entered a twenty-year land lease of airport property and were also made responsible for management of the Airport and FBO services. In 1977 Falcon Air, Ltd. took over as the operator at the Airport. In 1979 both Cities signed an Intergovernmental Agreement and assumed management responsibilities of the Airport.

Destination FNL:

At the heart of FNL's expansion efforts lies the ambitious new terminal project, a testament to the airport's commitment to modernization and enhanced passenger experience. This cutting-edge terminal is designed to seamlessly blend functionality with aesthetics, offering travelers a welcoming and streamlined journey from check-in to departure.

The new terminal boasts state-of-the-art facilities, including spacious concourses, modern boarding gates equipped with the latest technology, and an array of retail outlets and dining options to cater to diverse tastes and preferences. Whether passengers are looking for a quick bite before their flight or seeking to indulge in some last-minute shopping, the terminal provides a vibrant and inviting environment to meet their needs. Currently both Fort Collins and City of Loveland are responsible for management of the airport through the signed Intergovernmental Agreement (IGA), with Loveland being responsible for the day-to-day operations and personnel. The Cities' representatives on the Governance Board are preparing to meet in early July to begin discussions on a new model that would not involve both cities actively overseeing the Airport.

Furthermore, the new terminal at FNL prioritizes sustainability and environmental stewardship, incorporating eco-friendly features such as energy-efficient lighting systems, water-saving fixtures, and sustainable building materials. In addition to the terminal enhancements, FNL is also investing in upgraded runway infrastructure and expanded parking facilities to accommodate the growing demand for air travel in the region. 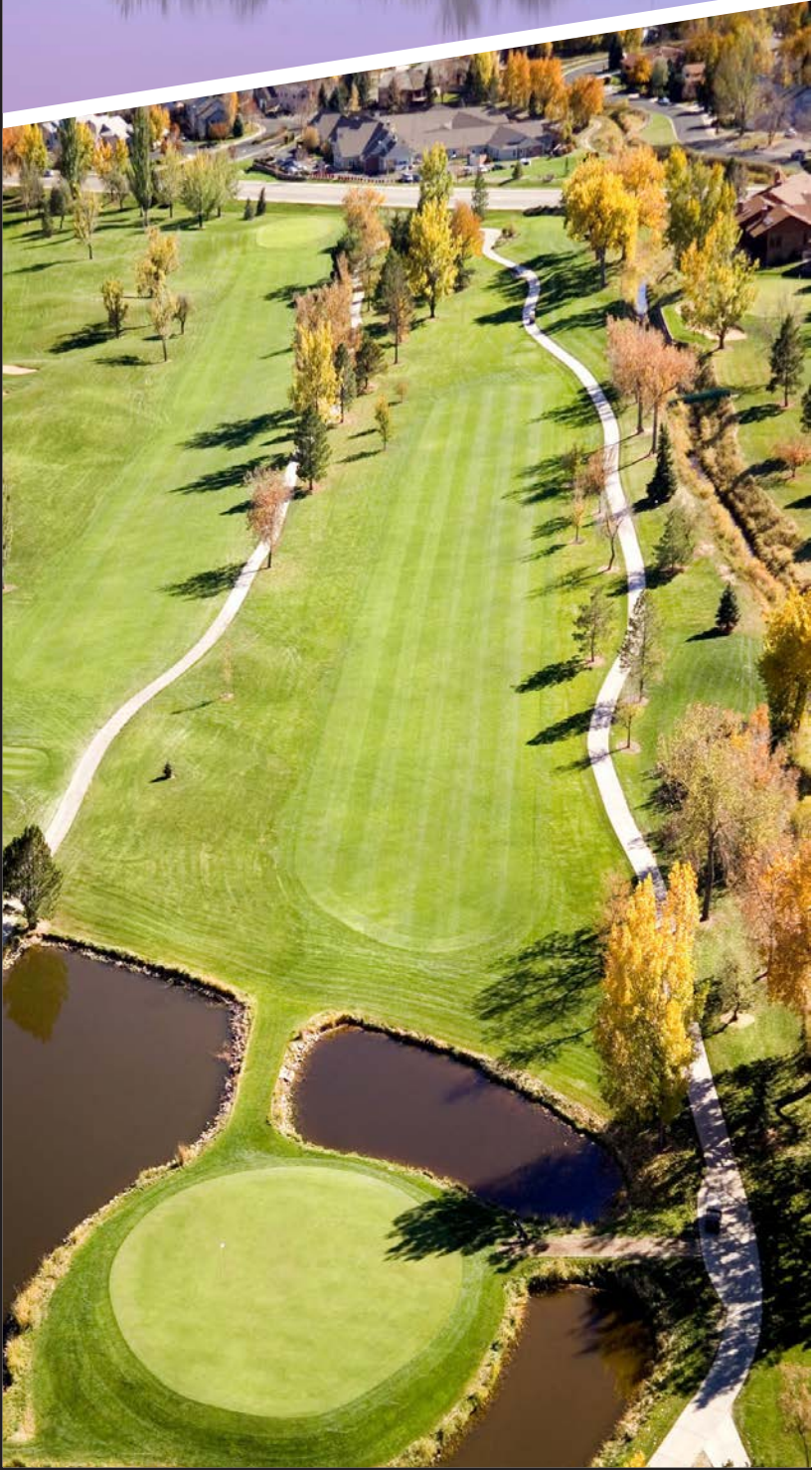
